### SECTION 4 : First aid measures

#### Description of first aid measures

**After inhalation:** Loosen clothing as necessary and position individual in a comfortable position. Move exposed to fresh air. Give artificial respiration if necessary. If breathing is difficult give oxygen. Get medical assistance if cough or other symptoms appear.
